Punch Bowl Inn Burton in Lonsdale

Do you want to tender for the following package of construction works at the Punch Bowl?

Introduction

Our community purchased the Punch Bowl on 4 July 2025. Volunteers have worked incredibly hard to clear and clear the pub in readiness for construction works. Given the Punch Bowl is a Grade 2 Listed building in a Conservation Area, we must obtain Listed Building Consent (LBC) for any construction works. Our application is under consideration. We hope to receive LBC in early August. In parallel we are in consultation with North Yorkshire Building Control to ensure we produce a compliant design. We hope to firm up a design by mid-August. At this point we will be in a position to seek tenders for the main part of the construction works.

It is important to our community that we seek tenders from locally based contractors where possible. It is also important that the successful contractor is familiar with working on a listed buildings and has the necessary workforce to meet our construction programme.

Scope of works

Please note we are seeking one tender for the full package of works.

The following provides an overview of the works to be tendered.

- 1. Reconfiguration of existing public toilets to provide 3 toilets including an accessible toilet with baby-change facilities. Briefly, the work will include the removal of existing toilet facilities, repositioning of partition walls, installing new toilet facilities, associated plumbing, ventilation and blocking off an existing door opening.
- 2. Removal of an existing internal wall in the public lounge area, insertion of a steel beam and all associated making good.
- 3. Removal of a steel column, insertion of a steel beam and all associated making good.
- 4. Removal of an existing single cubicle toilet, provision and installation of a timber staircase, along with associated fire compartmentation and access doors.
- 5. Creation of two en-suite guest bedrooms including associated plumbing and ventilation works and all necessary fire protection works.
- 6. Various associated fire protection works.

The following works are not included within the tender package:

- 1. Decoration including painting and tiling.
- 2. Floor finishes.
- 3. Electrical works including alarms, emergency lighting and ethernet cables. The successful contractor will be required to work with and alongside the electrical contractor who is carrying out work throughout the Punch Bowl. Please note, electrical works will be carried out by a fully qualified electrical contractor, **not** by volunteers.

- 2. Notify contractors of inclusion on tender list: 6 August 2025

- 3. Invitation to tender: 18 August 2025
- 4. Tender returns: 2 September 2025
- 5. Contract award: 10 September 2025
- 6. Commencement on site: 29 September 2025
- 7. Completion of the public toilet area (item 1 above): 20 October 2025
- 8. Completion of the balance of the works: 24 November 2025
